Established in 1990, the State Office certifies and provides training and support to local GAL/CASA volunteer programs. GAL/CASA volunteers and staff spend time with children involved in child abuse and neglect proceedings (CHINS cases) and provide child-focused recommendations to the court about what is in the child/ren’s best interests.

## General Summary of Indiana’s GAL/CASA Volunteer Programs in 2023

- Certified GAL/CASA volunteer programs in 87 of our 92 counties
- 2,966 active volunteers advocated for 18,478 children
- 470 new volunteers were trained in 2023, spending more than 14,000 hours in initial training

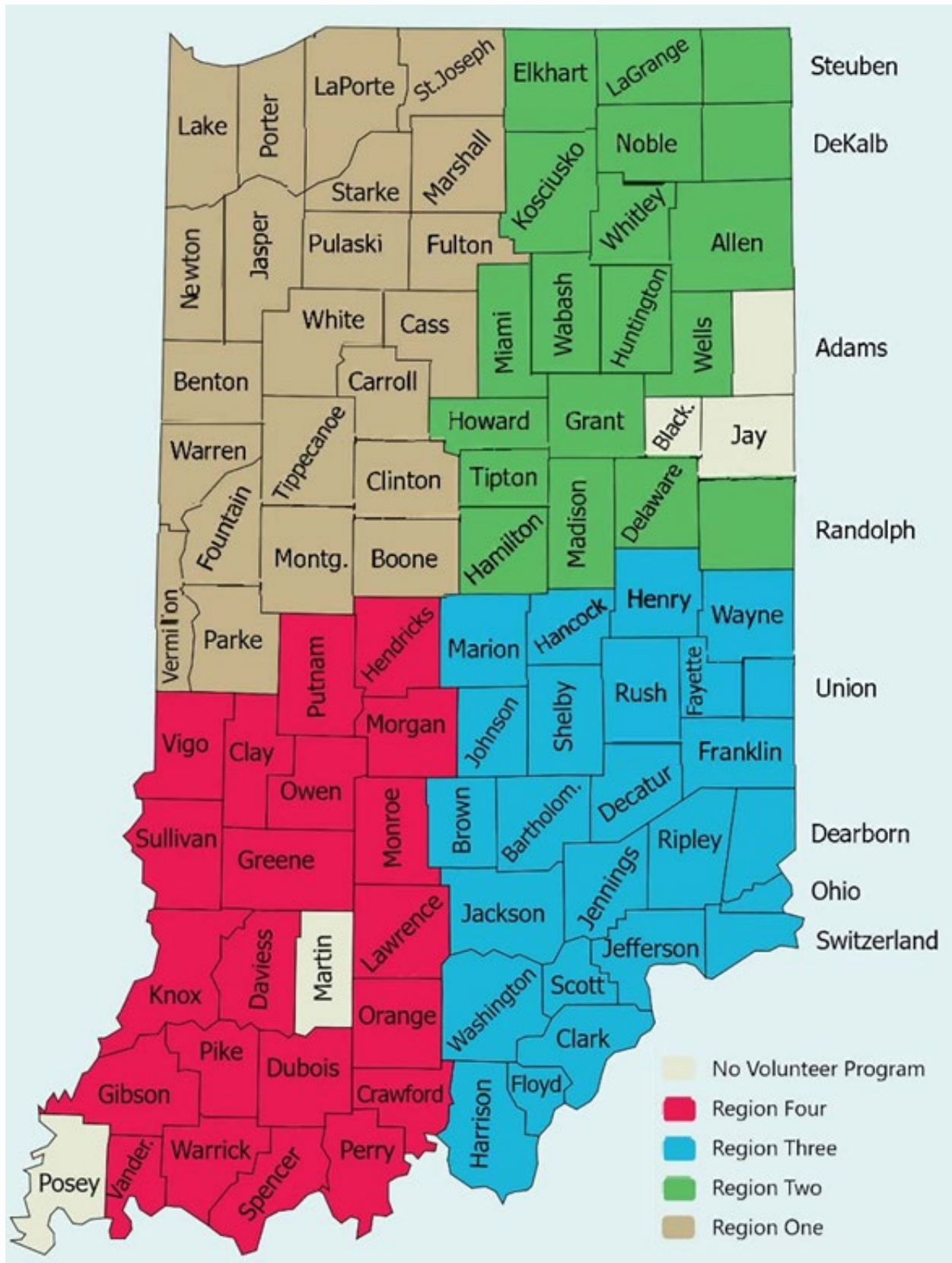
