

# Stabilization D&E

Stabilization diagnostic and evaluation programs are 60-day programs for youth who have been historically difficult to find appropriate placement for because of unstable behaviors and/or a need for psychological testing to determine treatment and accurate diagnosis. Testing should be completed and the written evaluation report, including recommendations, should be finalized and sent to the referral source by the 30th day of the youth's placement in the Stabilization D&E

program. The next 30 days should be spent reviewing the recommendations with Child and Family Team, planning for discharge/transition, and following up with the referral source about the next steps in treatment for the youth.
