- Troy Dulaney Investigation Summary and Board Recommendation March 10, 2023, a complaint was received regarding alleged cheating with EMS and Fire exams at Muncie Fire Department.
- 2. The complaint alleged that Troy Dulaney was leading a cheating scheme. An investigation took place which included thirty (30) interviews of witnesses, students, firefighters, and Dulaney.
- **3.** April 13, 2023, based on the evidence collected IDHS suspended indefinitely from employment.
- **4.** Evidence that was collected through the interviews was discussed. The evidence showed that Dulaney's misconduct ranged from 2018 2023. Exams included in the scheme were Fire Officer Strategy and Tactics, Rope Rescue Operations, and an EMT course.
- **5.** Dulaney's EMS certifications have been revoked for a period of seven (7) years.

6. Authority to Sanction:

655 IAC 1-1-7(b) – Revocation or denial of Certification – the board may take action with respect to the application for or certification of any fire service person...upon information provided to the board that the fire service person has: (1) failed to uphold and respect a student's right to privacy, dignity and safety....(3) failed to comply with the board rules.

Violations:

655 IAC 1-1-12(j)(12) – Application and testing procedures; appeals; challenges; reciprocity: A proctor shall not discuss any test question or possible answer thereto with any student taking the examination.

655 IAC 1-1-13(a)(4)(C) — Qualifications of evaluators and proctors: ...the qualifications for lead evaluator shall be as follows: Commitment to uphold the board's practices and policies.

IC 35-43-5-4(a)(3) – Fraud: A person who...possesses, manufactures, uses or alters a document, instrument, computer program, or device with the intent to obtain...an educational, governmental or employment benefit to which the person is not entitled... commits fraud, a Class A misdemeanor.
