- Debbie Sampson via Melanie Brizzi informed the committee that a draft bill was passed by the Child Care Committee that requires CCDF providers to have twelve (12) hours of workshop/trainings or continuing education credits annually.
- The bill also would allow all provider types access to CHIP to check immunization records.
- Karen Burnside-Strack from Fort Wayne has decided to retire and closed her child care in September. She is resigning from the committee
- The Bureau will be hiring a new licensing consultant to replace Yvette Williams. Nancy Chew will be taking over Yvette Williams' territory. The open position will be located in Marion and Boone Co.

- Melissa Chalman from IACCRR informed the committee that Child Abuse and Neglect Detection and Prevention one (1) hour training is available on the IACCRR website. This training course is available in webinars and one (1) hour classes.

- Please make sure you have your abuse and neglect prevention certificate. Your licensing consultant will request to see your certificate. This has always been a requirement. All child care providers, staff and volunteers are required to have this certificate.
- Please take the time to go register for the Breathe Safe Tool Kit. The kit is free. The web address is Breatheasyindiana.com.
- Stephanie McKinstry informed the committee to start the CDA renewal process early. Take in mind that the dates and requirements for renewal have changed. Take in mind the observers expect to be paid for coming to your daycare and observing.
- The 2014 committee meeting dates are as follows: Jan. 28th, April 22nd, July 22nd, and Oct. 28th. The new meeting dates will be posted online. A telephone number and passcode will be sent later.
- Tammy Dunn suggested that each committee member put together a list of topics that they
