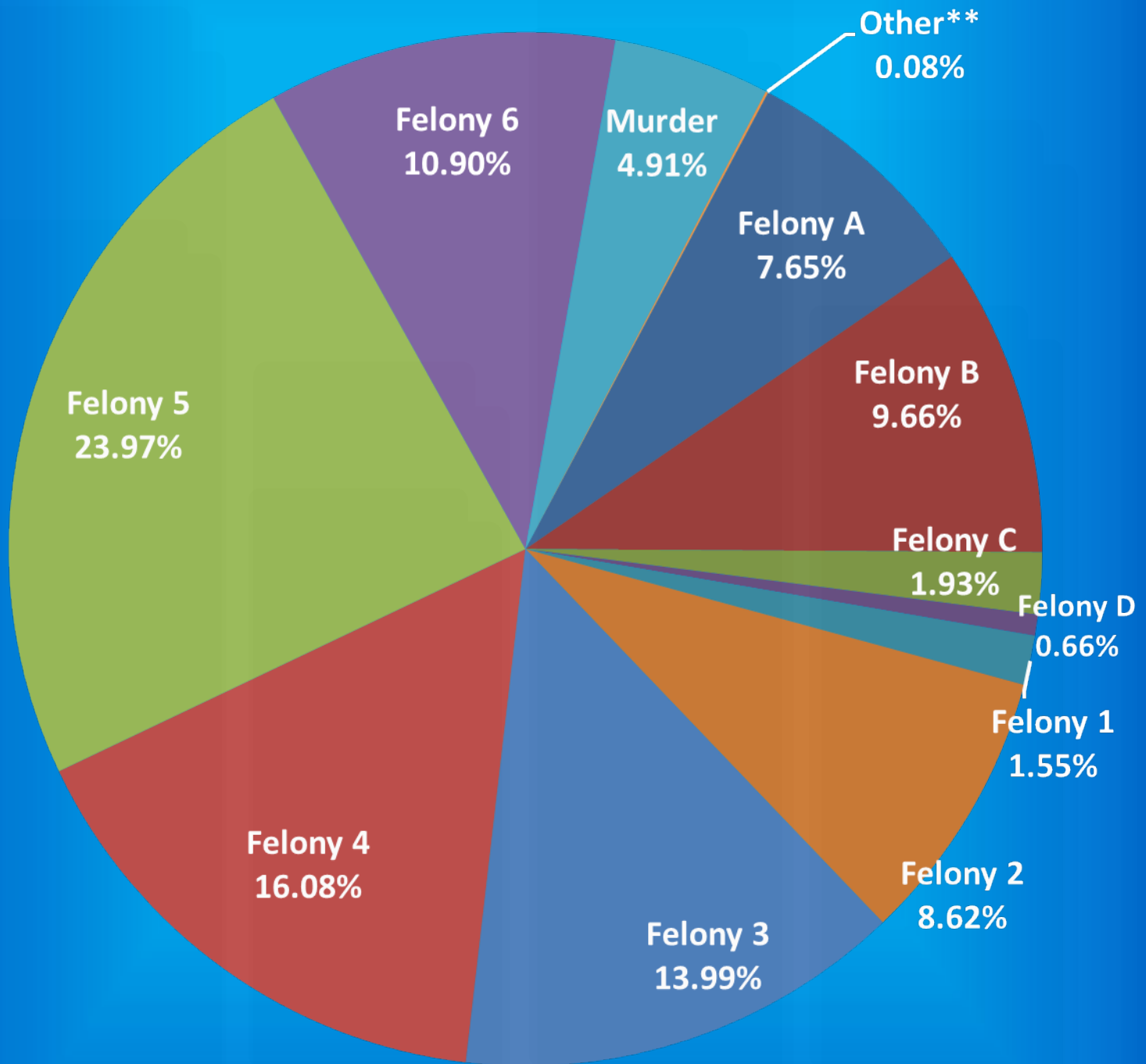

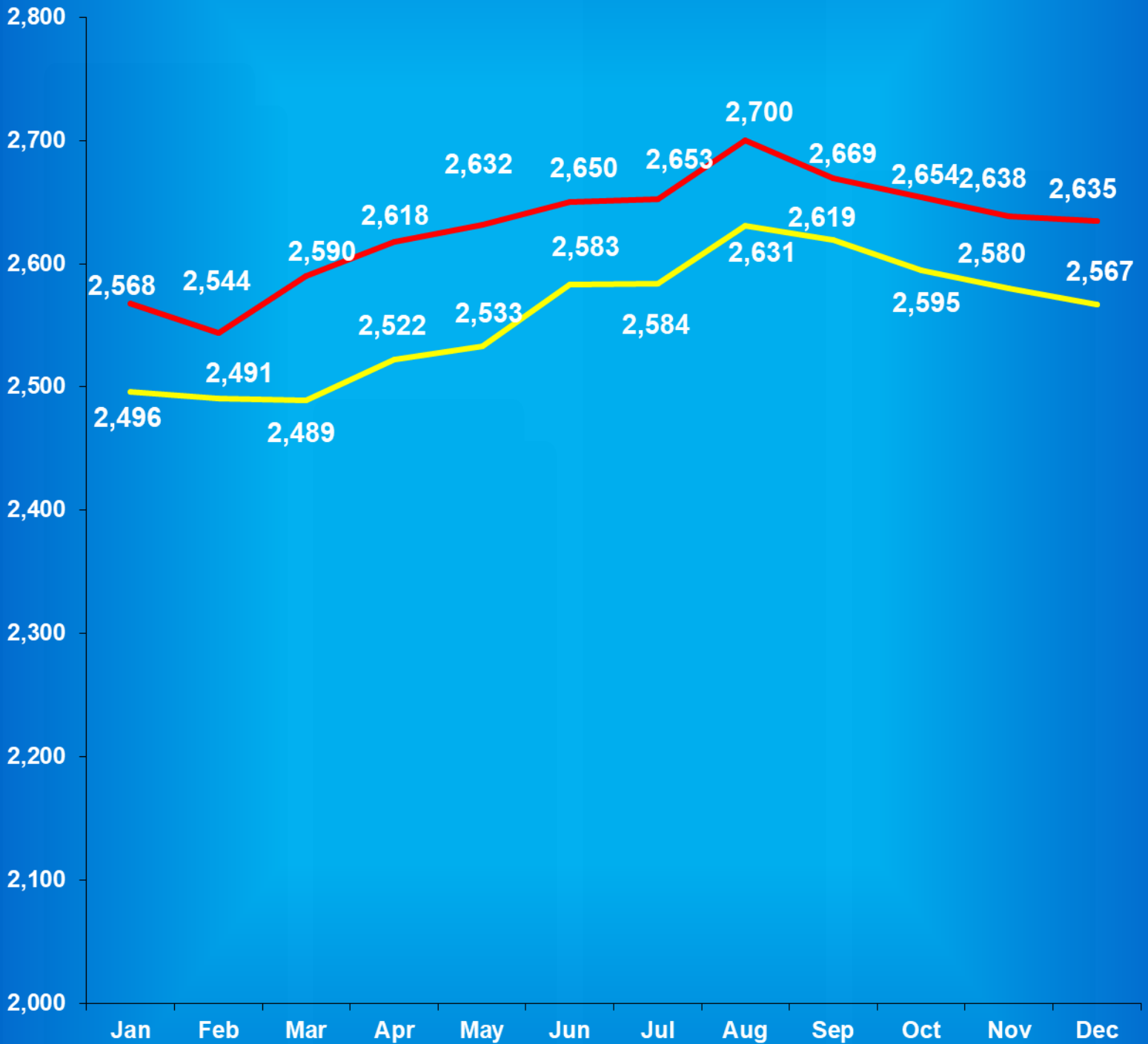

Calendar Year 2019

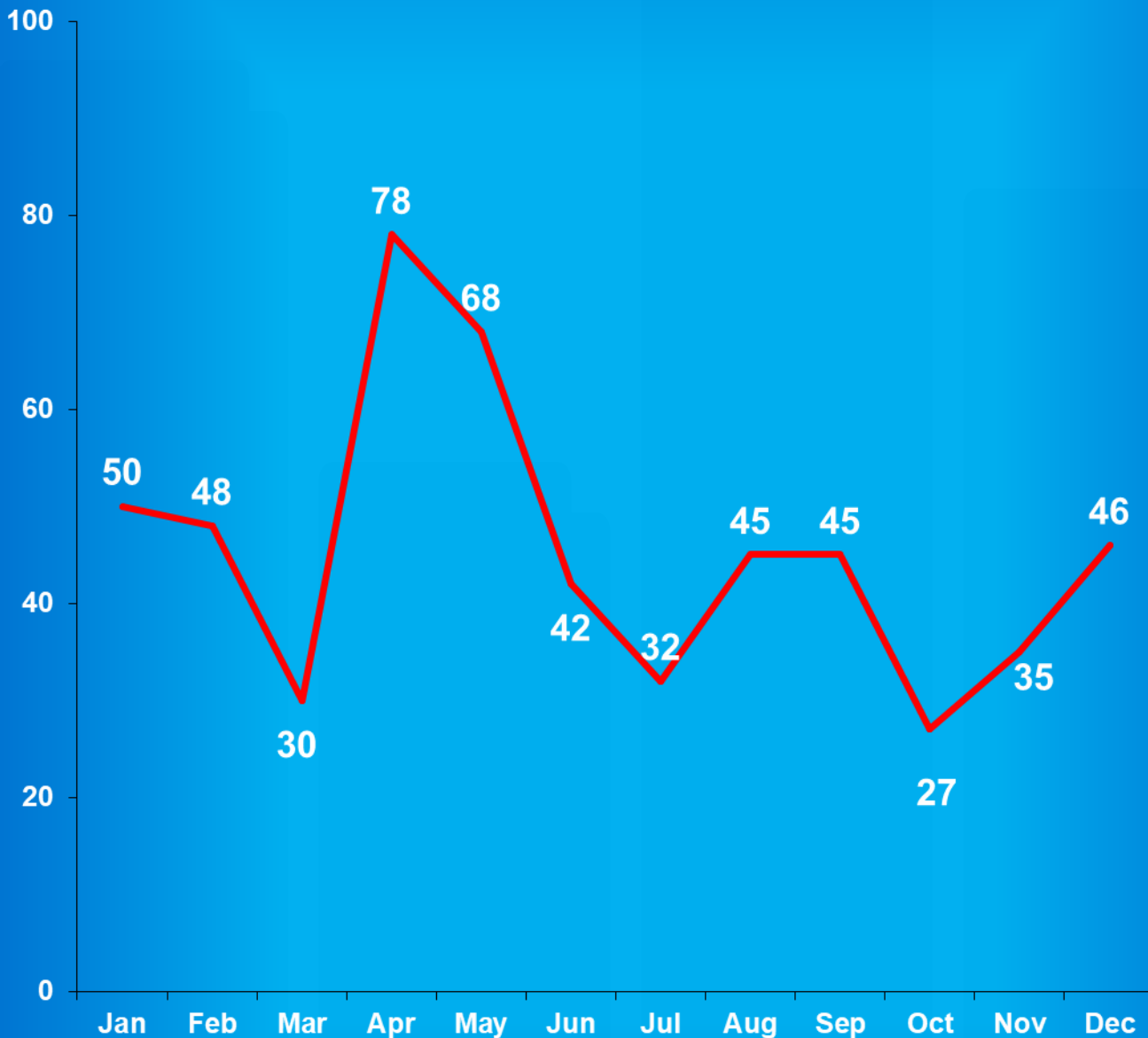

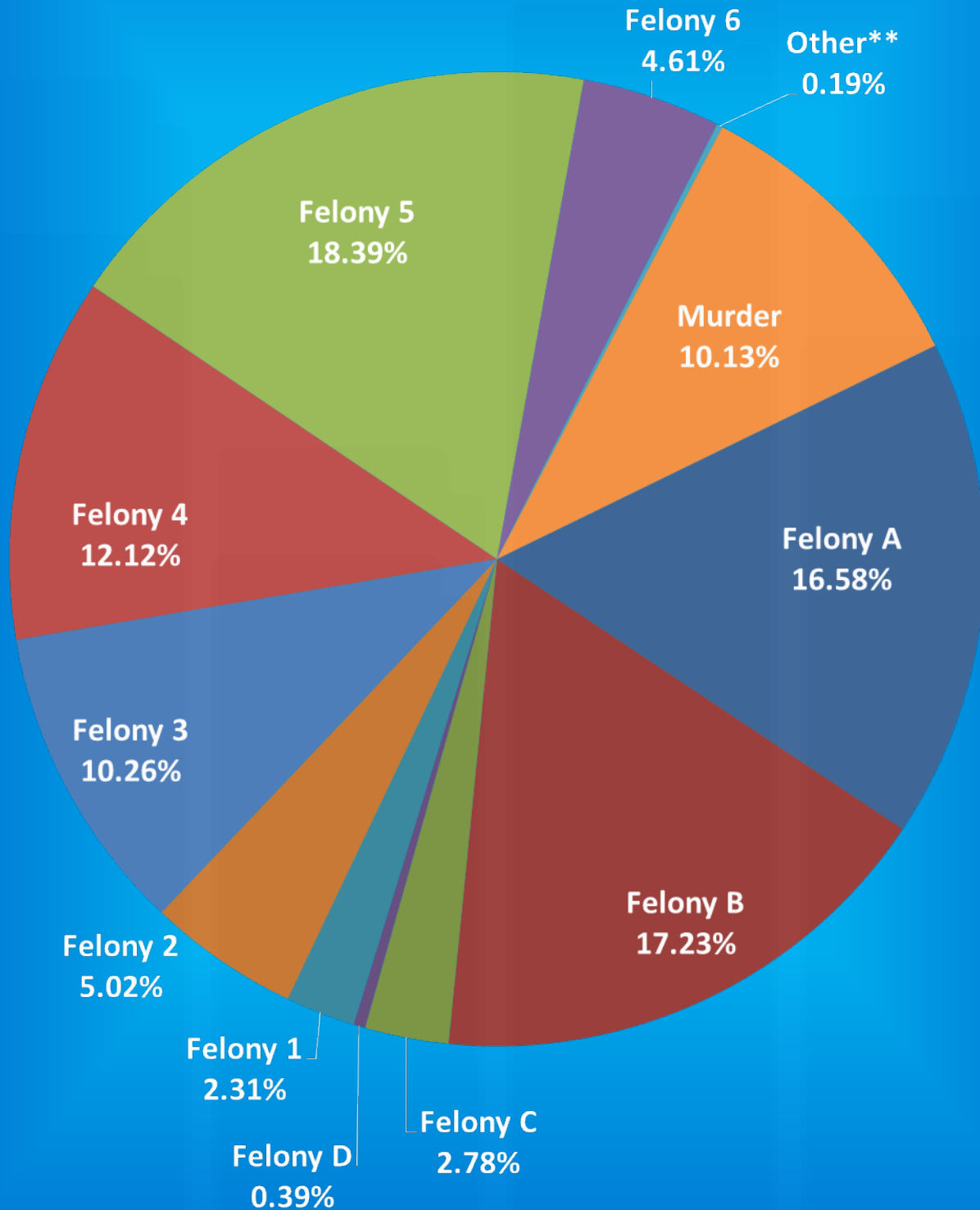

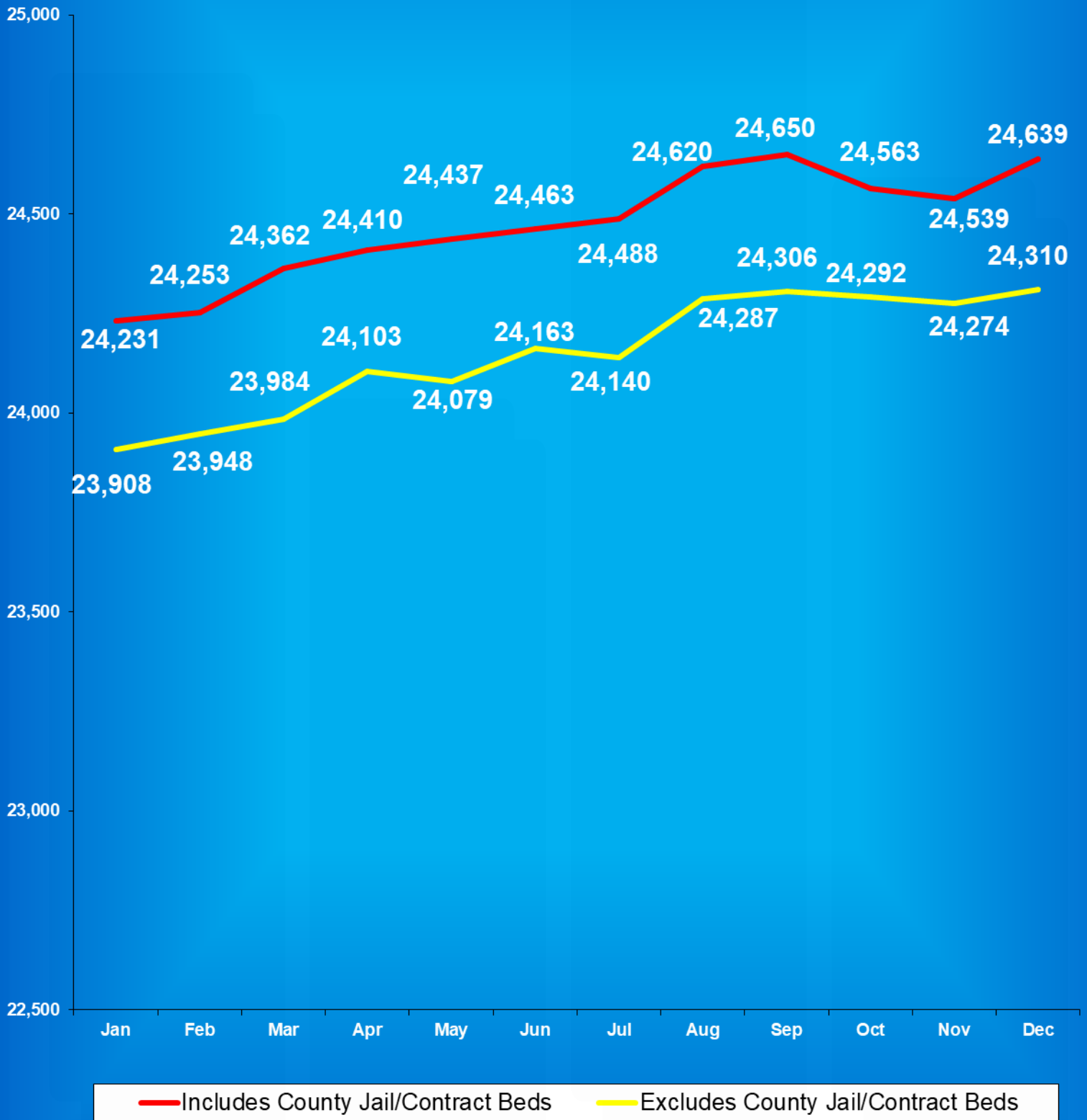

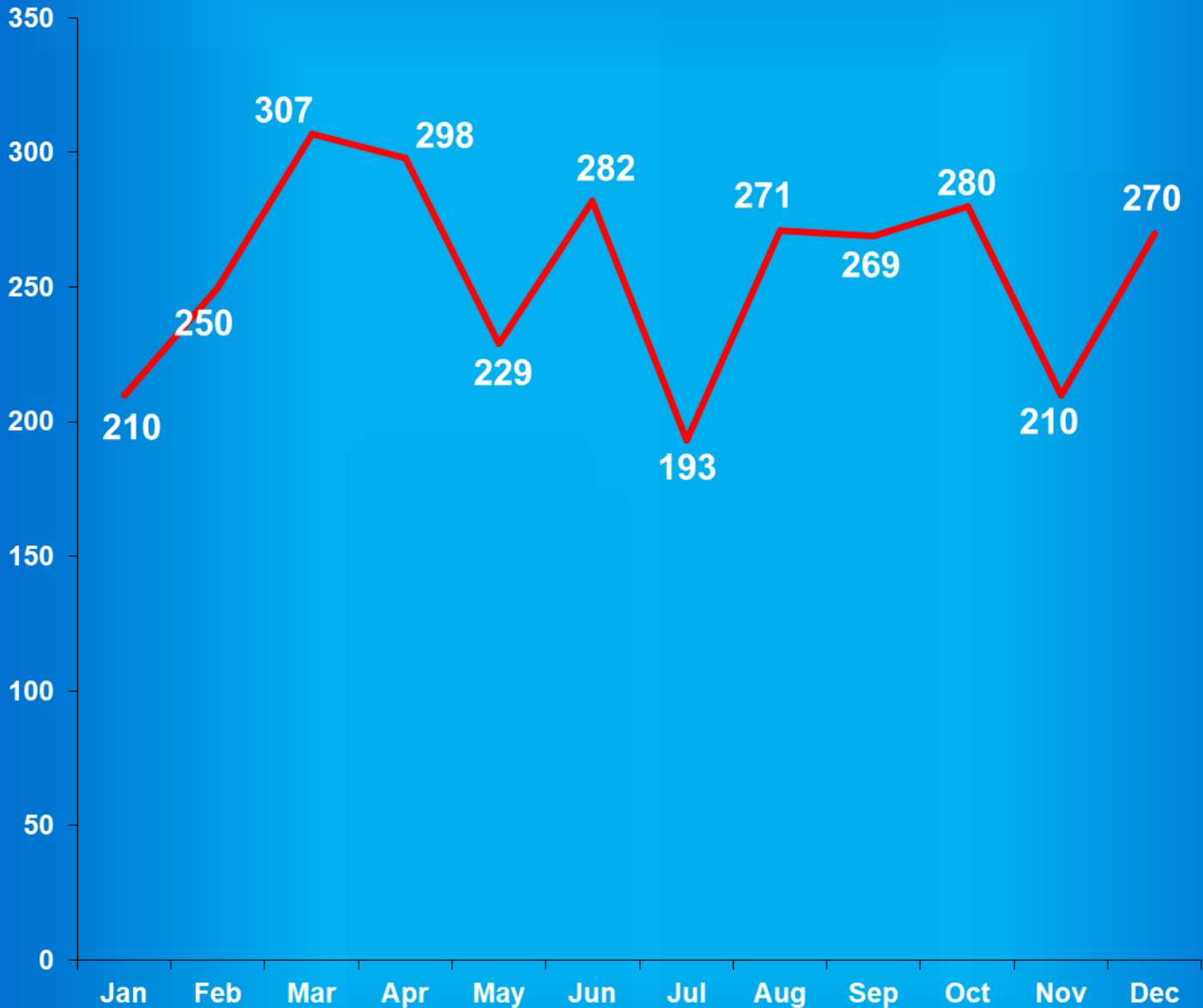
Average Daily Adult Male Offender Populations Calendar Year 2019

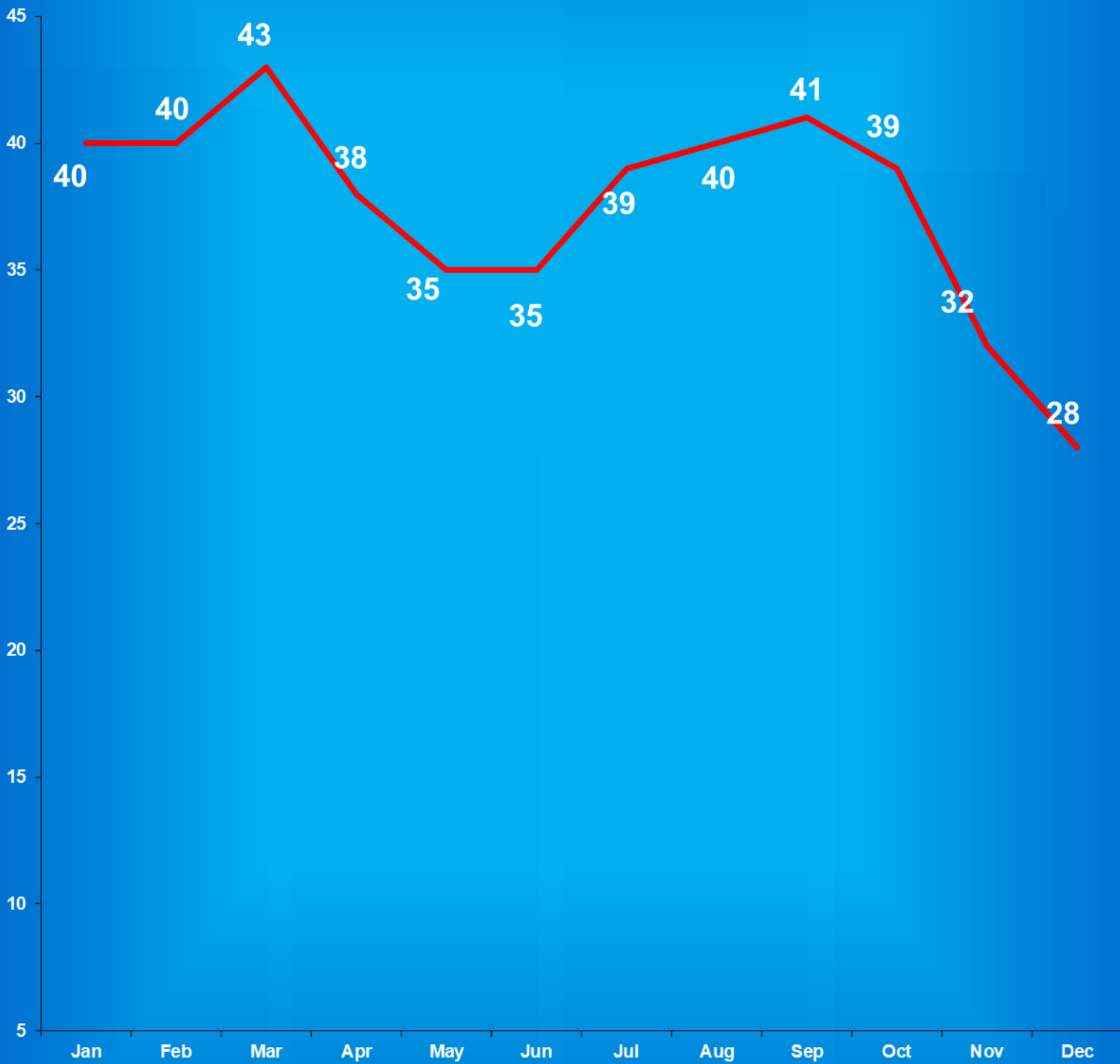

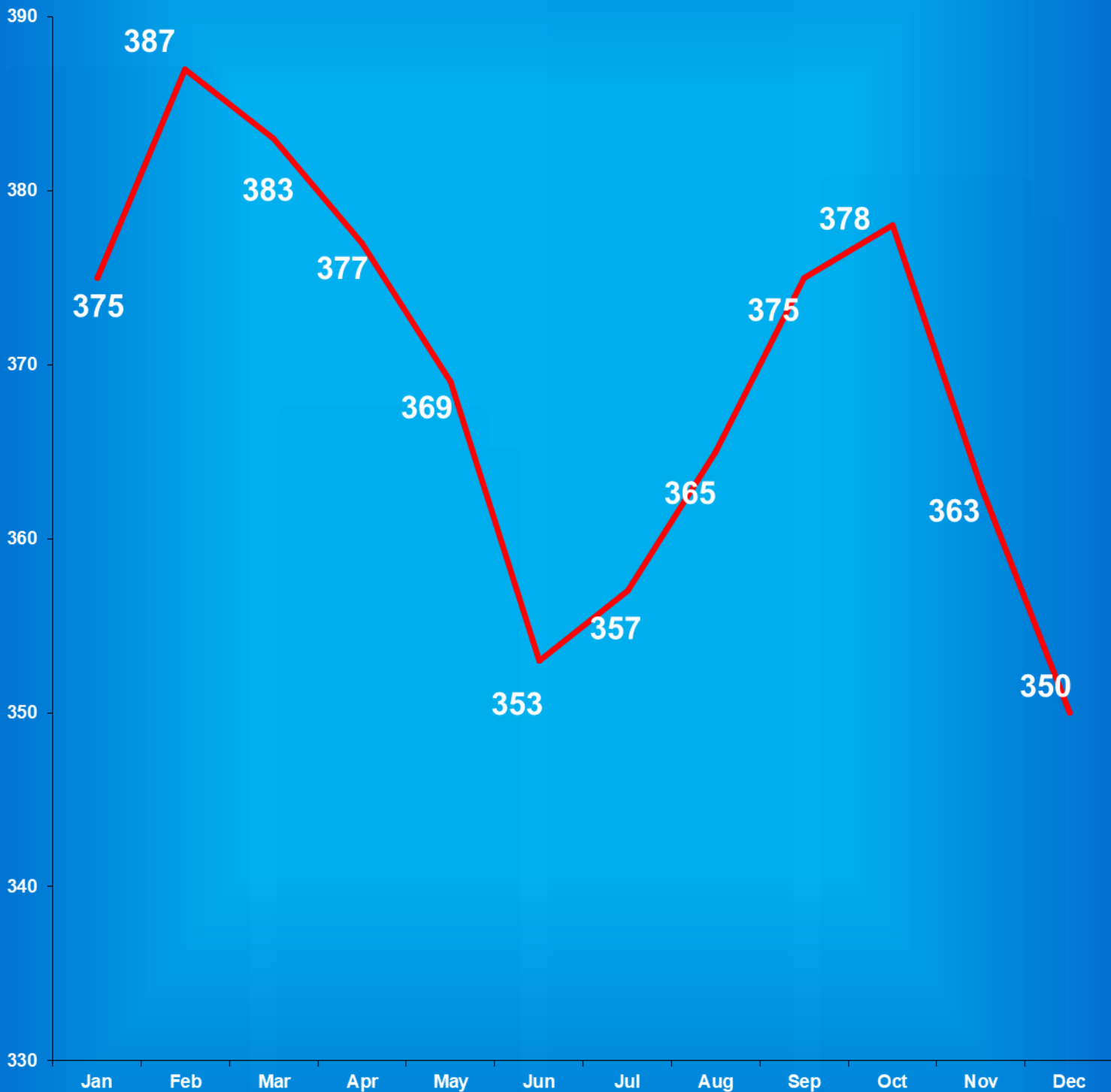
