

RESOLUTION 1997-32

A RESOLUTION GRANTING PERMANENT SUPPLIER'S LICENSES

The Indiana Gaming Commission("Commission") adopts the following resolution pursuant to the authority granted to it under IC 4-33 and pursuant to 68 IAC 1-2-6:

The following factors have been considered by the Commission:

1. In accordance with IC 4-33-8 and 68 IAC 2-2, suitable applicants for an Supplier's license are issued a temporary supplier's license pending the completion of a background investigation.
2. Temporary supplier's licenses were issued to applicants to supply goods and services to gambling operations licensed by the Indiana Gaming Commission.
3. The Commission has completed background checks on the temporary supplier licensees listed below and is ready to issue permanent supplier's licenses to the following:

GEMACO Playing Card Company
Mikohn Gaming Corporation
Paul-Son Gaming Supplies, Inc.
Bud Jones Company, Inc.
Osborne Coinage Company

NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING COMMISSION, THAT THE FOLLOWING RESOLUTION IS ADOPTED:

SECTION 1. SCOPE.

This resolution applies to all Temporary Supplier's listed above in Number Three (3).

SECTION 2. DEFINITIONS.

The definitions set forth in IC 4-33-2 and 68 IAC apply to this resolution.

SECTION 3. GRANT OF PERMANENT SUPPLIER'S LICENSE FOR QUALIFIED APPLICANTS.

The Commission hereby grants permanent supplier's licenses to the temporary suppliers licensee listed below. The permanent supplier's license will be valid for a period of one (1) year, from August 19, 1997 through August 18, 1998.

GEMACO Playing Card Company
Mikohn Gaming Corporation
Paul-Son Gaming Supplies, Inc.
Bud Jones Company, Inc.
Osborne Coinage Company

SECTION 4. CONDITIONS PLACE ON SUPPLIERS LICENSES.

- A. Issuance of the permanent supplier's license is conditioned upon payment of the appropriate licensure fee and the cost of the license investigation by the temporary supplier by September 16, 1997. Failure to remit payment may result in the revocation of their license.
- B. The Suppliers licensee must request renewal of the suppliers at least thirty (30) days before the expiration of the permanent suppliers license in accordance with 68 IAC 2-2-8.

SECTION 5. EFFECTIVE DATE.

This RESOLUTION is effective immediately.


