

RESOLUTION 2002-25

A RESOLUTION APPROVING FOR FINAL READOPTION ARTICLES 3, 5, 10, 11, 12, 13, 14, 15, 16, 17, 18 AND 19 OF TITLE 68 OF THE ADMINISTRATIVE CODE

The Indiana Gaming Commission ("Commission") adopts the following resolution pursuant to the authority granted to it under IC 4-33 and pursuant to 68 IAC 1-2-6.

The Commission has considered the following factors:

1. Under IC 4-22-2.5, rules adopted under IC 4-22-2 expire January 1, of the seventh year after the year in which the rule takes effect, unless the rule contains an earlier expiration date.
2. The Commission caused a Notice of Intent to Readopt to be published in the *Indiana Register* on January 1, 2002. The notice included for Readoption the following Articles of Title 68: Articles 3, 4, 5, 10, 11, 12, 13, 14, 15, 16, 17, 18 and 19.
3. A Proposed Notice to Readopt was published in the *Indiana Register* on May 1, 2002. Although a public hearing was originally scheduled for June 4, 2002, a Change in Notice of Hearing was published in the July 1, 2002 edition of the *Indiana Register* and the hearing was held on August 6, 2002. A written request for separate consideration of Article 4 was received and therefore it will be considered separately from the above-listed rules; no other written comments were received. There were no oral comments made at the hearing.
4. Pursuant to IC 4-22-2.5-4, if the Commission approves this resolution, the Commission staff will submit the rules for filing with the Secretary of State under IC 4-22-2.5-4 and publish notice in the *Indiana Register* that the agency has readopted the rules.

**NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING COMMISSION,
THAT THE FOLLOWING RESOLUTION IS ADOPTED:**

SECTION 1. SCOPE.

This RESOLUTION applies to each applicant, each licensee, each riverboat license applicant, any person who does business with an applicant or licensee, and any person who is a patron of a Riverboat Gambling Operation.

SECTION 2. DEFINITIONS.

The definitions set forth in IC 4-33-2 and 68 IAC apply to this resolution.

SECTION 3. READOPTION OF THE RULES.

The Commission readopts the following rules:

SECTION 4. EFFECTIVE DATE.

This RESOLUTION is effective immediately.

SECTION 5. EXPIRATION DATE.

This RESOLUTION expires thirty (30) days from the date and time that the Secretary of State accepts the rules listed in Section 3 for filing.
