RESOLUTION 2002-36

A RESOLUTION CONCERNING THE RENEWAL OF A SUPPLIER'S LICENSE

The Indiana Gaming Commission ("Commission") adopts the following resolution pursuant to the authority granted to it under IC 4-33 and pursuant to 68 IAC 1-2-6:

The Commission has considered the following factors:

- 1. On December 6, 2001, by RESOLUTION 2001-41, a Supplier's License was issued to Tech Innovations, Inc.
- 2. In accordance with IC 4-33-7-8 and 68 IAC 2-2-8, a Supplier's License must be renewed annually.
- 3. Tech Innovations, Inc. has requested a renewal of licensure. The renewal will be conditioned upon payment of the renewal fee in accordance with 68 IAC 2-2-3(c) and 68 IAC 2-2-8. If payment of the renewal fee is not received as directed by the Commission Staff, the license will be subject to revocation. The Supplier Licensee may have outstanding background investigation fees and will be responsible for payment of the background fees. If payment for the background fees is not received as directed by the Commission staff, the license will be subject to non-renewal or revocation.
- 4. The Commission has determined that Tech Innovations, Inc. remains in compliance with IC 4-33.

NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING COMMISSION, THAT THE FOLLOWING RESOLUTION IS ADOPTED:

SECTION 1. SCOPE.

This resolution applies to Tech Innovations, Inc.

SECTION 2. DEFINITIONS.

The definitions set forth in IC 4-33-2 and 68 IAC apply to this resolution.

SECTION 3. GRANT OF RENEWAL OF SUPPLIER'S LICENSE.

The Commission hereby grants the renewal of the Supplier's License issued to the supplier listed below on the condition that any outstanding background fees are paid as directed by the Commission staff. The renewed Supplier's License will be valid for a period of one (1) year from the date of issuance.

TECH INNOVATIONS, INC.

SECTION 4. CONDITIONS PLACED ON SUPPLIER'S LICENSE.

The Supplier Licensee must request renewal of the Supplier's License at least thirty (30) days before the expiration of the license and pay the renewal fee in accordance with 68 IAC 2-2-3 (c) and 68 IAC 2-2-8.

SECTION 5. EFFECTIVE DATE.

This RESOLUTION is effective immediately.
