We have reviewed the State Transportation Improvement Program (STIP) amendment request you submitted via correspondence dated July 6, 2016. This request adds projects pursuant to changes made to the Transportation Improvement Program (TIP) for:

- Madison County Council of Governments (MCCOG) and
- Northwestern Indiana Regional Planning Commission (NIRPC).

The amended TIP has been endorsed by the appropriate Metropolitan Planning Organizations (MPOs). The projects listed in the attached table are eligible for FTA funding.
